CUSTOMERS FIND NEW APPLICATIONS FOR EQUATION® SOFTWARE

One of the largest US Airlines joined our list of customers in February 2012. Their primary use of the platform is to electronically perform audits throughout their flight operations. They began with 40 users and by the end of 2012 had expanded usage to over 500 users. Outside contractors clean their aircraft and their internal auditors use equation[®] ASP to record and analyze the cleaning product and process. Their newest use for our system is to schedule cleaning events for their suppliers.

A large federal government supplier has used equation to record and track data in one of its health and sciences departments since 2006. They are now in the process of replacing an internal software system with equation[®] ASP. Rewrite and application requirements are under way with project completion by YE 2013.

A large Native American tribe, along with Prism technical writers developed a Land Management System to simplify and streamline a complex and sophisticated land ownership process. The US Bureau of Indian Affairs has now approved this Land Management System for use by all Indian Tribal Nations. System design, dedicated servers, migration of data, file transfer protocols, etc., will be completed on or about January 2014.

One of our nation's largest steel manufacturers began equation use as part of their ISO 9001 Certification. Since then they have expanded its use far beyond certification and document control applications. We recently assisted them in completing a "Lock Out/Tag Out" process to manage physical access to plants. Truck drivers, licenses and driving records are tracked, accessed, and control access to their plants.
